2. Minutes from the February 22, 2022 Board Meeting approval: No edits were made after distribution and review by the Board members.

Julia Hibbs motioned to approve the Minutes from the February 22, 2022 Board Meeting as presented. Zanndra Enriquez seconded. Karen Kordon, Zanndra Enriquez, Daniel Waterman, and Julia Hibbs voted in favor of the motion. Motion carried 4-0.

- 3. Discussion and Possible Board Action
 - a. SY22.23 Annual Calendar approval. No discussion or edits.

Zanndra Enriquez motioned to approve the SY22/23 Annual Calendar as written. Daniel Waterman seconded the motion. Karen Kordon, Zanndra Enriquez, Daniel Waterman, and Julia Hibbs voted in favor of the motion. Motion carried 4-0.

b. SY22/23 Prop 301 Disbursements. Increasing annual disbursements to \$6000 per certified teacher. \$3600 will be designated to 011 & 012, base salary and \$2400 to 013, performance pay. Zanndra Enriquez asked how often the funds are reviewed. Karen answered annually, based on enrollment.

Karen Kordon motioned to approve the SY22/23 Prop 301 Disbursements as written. Daniel Waterman seconded the motion. Karen Kordon, Zanndra Enriquez, Daniel Waterman, and Julia Hibbs voted in favor of the motion. Motion carried 4-0.

c. Teacher Salary Increase Structure. Proposal to change the salary increase structure for teachers to 1% per year, contingent on enrollment, funding and prior year evaluation instrument. Zanndra Enriquez asked about other salary increase structures. Karen Kordon answered they have not been addressed yet.

Karen Kordon motioned to approve the Teacher Salary Increase Structure as written. Daniel Waterman seconded the motion. Karen Kordon, Zanndra Enriquez, Daniel Waterman, and Julia Hibbs voted in favor of the motion. Motion carried 4-0.

- d. Amended PUA. Our landlord has raised our rent to \$13.68/sqft. Although it's an increase, it is still \$12.00/sqft under the going commercial rate.
