TAX CREDIT FACTS

- Anyone with or without children, married or single is eligible for this state TAX CREDIT.
- The \$400 maximum state TAX CREDIT is available for taxpayers who are married and filing jointly.
- The \$200 maximum state TAX CREDIT is available for single individuals or a head of household.
- A State TAX CREDIT will allow you to reduce the amount of your tax liability to the state or increase your refund from the state.
- You may donate less than the maximum and be eligible to receive the state TAX CREDIT in the amount of your donation. You
- can make a difference with a donation of \$75, \$100, or \$200.
- Your donation also reduces your taxable income to the federal government, thereby reducing your federal tax burden usually by 1/3 of the donation amount.
- You must complete and file Arizona tax form 322 with your state return to receive TAX CREDIT for your donation.
